## **NOTIFICATION**

As per the approval of the Department vide U.O. No.28/Min./HE/2021 dated 04/03/2021 the Government of Tripura in Higher Education Department has revised the examination pattern of Tripura Board of Joint Entrance Examination (TBJEE) for distribution of seats of professional degree colleges through counseling process by TBJEE.

- i) In place of two (02) days examination pattern consisting of four (04) shifts, from the year 2021, TBJEE shall conduct examination in a single day with three (03) shifts system.
  - (a) 1<sup>st</sup> shift of examination in the subject of Physics and Chemistry combined for 01 hour and 30 minutes.
  - (b) 2<sup>nd</sup> shift of examination in the subject of Biology for 45 minutes and 3<sup>rd</sup> shift for Mathematics for 45 minutes.
  - (c) The rest period between two successive shifts of examination will be determined by the TBJEE.
- ii) In the revised examination pattern, first shift will be consisting of Physics and Chemistry in a single and combined question paper, and subsequent two shifts will be consisting of Biology and Mathematics in separate question paper as per the decision of the Board. All the question papers are of MCQ type and duration of examination for each subject irrespective of group will be 45 minutes.
  - (a) Each subject shall be divided into 10 modules; and, from each module, number of questions will be three (03) and each module will covers a total of 12 marks.
  - (b) Each question will carry four (04) marks instead of two (02) marks.
- iii) Number of questions in each subject will be 30 instead of 50; and, full marks of each subject will be 120 marks.
  - iv) There will be 1/4th (i.e., 01 mark) negative marking for each wrong answer.
- v) Each question will have four options (i.e. A, B, C, D) out of which the correct/ closest option (A/B/C/D) is only to be identified in the OMR sheet.





vi) The Percentile score system shall be implemented for the publication of result showing the common merit rank.
