EDUCATIONAL NOTIFICATION

Notification No. 5/2010.

Dated, Agartala, the 7th August, 2010.

The Department of Higher Education, Govt. of Tripura, has placed **170 seats of TIT, Agartala**, to the Board for distribution of those seats vide Educational Notification No.F2(362)-DHE/ GTCA/ 99(L) dated 06.08. 2010.

Counselling of all eligible candidates of **Tripura Joint Entrance Examination, 2010** for allotment of seats of **Tripura Institute of Technology (TIT), Narsingarh, Agartala**, made available to the Board will be held on **11th August, 2010, and 12th August, 2010** at **Town Hall, Agartala**.

It may be that, allocation of more seats for different Professional Courses, particularly from Central Pool (B.E./B.Tech in Civil, Mechanical, Electronics, Computer Science, etc for PCM Group) would be available to TBJEE for distribution among eligible candidates prior to commencement of the Counselling as per this Notification.

In that event, the counselling for distribution of those seats would also be held simultaneously.

Further Notification regarding availability of such seats may not be possible to be issued prior to counselling.

The eligible candidates of PCM group of TJEE, 2010, are hereby directed to appear before the Board at their own cost as per the following schedule:

*In addition to these seats, **4seats for candidates of PH category** and **2 seats for candidates of Ward of Ex-SM** are kept reserved, which may be distributed by TIT, Narsingarh separately vide letter No. F.2(362)-DHE/GTCA/99(L) dated 6th August, 2010.

More details, particularly regarding reservation of these 170 seats (for UR, ST & SC candidates) as per Govt. rules, will be notified by the sponsoring department in due course.

All eligible candidates, interested in availing the above mentioned seats, are directed to appear before the Board on the date, time & place as mentioned with the original H.S. (+2 stage) mark sheet along with two attested copies of H.S. mark sheet, upto-date Permanent Residence Certificate/ PRTC, Admit Card of TJEE, 2010 and all other documents they were required to submit with their applications for appearing TJEE,'2010. **The candidates are also directed to remain present sharp at the time of commencement of the counselling-session specified for them.**

No candidate will be considered for allotment of any seat unless he/she appears personally before the Board at the time of counselling.

It is to be noted that the selection of candidates for a particular course to a certain College/University will be subject to the fulfillment of eligibility criteria of the respective College/University.

Allotment of vacant seats, if any, under any category will be filled up by applying method of exchange as per Govt. Rules.

No separate call letter will be issued to any candidate.

If a candidate is allotted a seat this year or in the past inside or outside the State on the basis of result of Tripura Joint Entrance Examination, he/she will not be considered for allotment of seats unless he/she has surrendered the allotted seat in writing within the specified time to the appropriate authority and produce the necessary proof for that at the time of counselling.

ONLY THE CANDIDATE AND HIS/HER ONE GUARDIAN WILL BE ALLOWED TO ENTER THE COUNSELLING HALL.
