**Allotment of vacant seats, if any, under any category will be filled up by applying method of exchange as per Govt. Rules.**

**No separate call letter will be issued to any Candidate.**

**If a candidate is allotted a seat this year or in the past inside or outside the state on the basis of result of Tripura Joint Entrance Examination, he / she will not be considered for allotment of any seat unless he / she has surrendered the allotted seat in writing within the specified time to the appropriate authority and produce the necessary proof for that at the time of counselling.**

**ONLY THE CANDIDATE AND HIS/HER ONE GUARDIAN WILL BE ALLOWED TO ENTER THE COUNSELLING HALL.**
