Subject:- Approval of new methods to be adopted for conducting TJEE and Counseling process thereof.

To

With reference to the subject cited above I am to state that in consideration of the resolution of the special Board meeting of Tripura Board of Joint entrance Examination issued vide No. nil dated 2-11-2011, that the Government has decided to approve the following issues for taking necessary action from your end.

- 1) There will be 50 compulsory MCQs carrying 2 marks in each covering all the 4(four) subjects having 5 questions from each module. Full marks for each question paper will be 100 & duration of exam of each paper will be 2 hours. No mark will be deducted for wrong answer/s.
- 2) Spot computerized counseling may be done as per advice of the committee, formed by the Deptt. having expertise to deliver the method.
- 3) There will be no wait list of the candidates, at the time of counseling. In successive occasions, fresh counseling will be held as per procedure.
- 4) The Board conducts first round of counseling. Successive round of counseling would be conducted by the concerned Deptt. sponsoring such seats. As regards counseling of technical seats, the Deptt. of H.E. shall conduct further counseling through the Chairman and other members as decided by the Deptt., like current year or as per the prevailing situation as deemed fit.
- 5) The Deptt. is required to collect fresh eligibility criteria for admission of students in each of the institution where seats are sponsored by GOI and all the institutions within the State, for want of which aspiring students suffer physically and financially. Therefore, each of the sponsoring Deptt. would have to collect eligibility criteria of admission of students from such institutions where seats are allotted.

6) In case of surrendering of seats by any student, he/she has to surrender in writing to the appropriate authority within 7 (seven) working days from the date of selection through counseling. In this regard, exchange of seats in interdepartmental vacancies of any college or institution will not come in the purview of the TBJEE.

You are, therefore, requested to please issue the examination Notification as per above and take necessary action for implementing the same for the year 2012.
